The U.S. Chemical Safety and Hazard Investigation Board is currently investigating dust explosions that occurred in 2003 at WestPharma, CTA Acoustics, and Hayes-Lemmerz, and is likely to recommend that companies that handle powders or whose operations produce dust pay more attention to

understanding the hazards that may exist at their facility. This new CCPS guidelines book will discuss the types of hazards that can occur in a wide range of process equipment and with a wide range of substances, and will present measures to address these hazards.

The Industrial History of England

This book explains the procedures for evaluation potentially harmful exposures to people from hazardous materials, including chemicals, radon, and bioaerosols. The author provides practical information on how to perform air sampling, collect biological and bulk samples, evaluate dermal exposures, and determine the advantages and limitations of a given method. The original edition published in 1991 has been a valuable resource for Industrial Hygienists, safety professionals, environmental specialists, chemists and others involved in measuring airborne exposures to chemicals, microorganisms, and radon. However, much of the equipment-specific information is outdated and so the equipment described and illustrated in the book is either no longer available or does not represent state-of-the-art monitoring techniques. Additionally, the audience for the book can be increased to include public health specialists and emergency responders by adding chapters covering information monitoring during emergency response, including bio-terrorism agents such as anthrax.

topic entries arranged alphabetically, some with lists. Appendices include a fire related data table for higher risk chemicals, indexes of registry numbers and chemical names as well as reference abbreviations and a glossary.
